Right of Withdrawal

1. Right of cancellation

If you are a consumer, you have a legal right of cancellation, so that you can cancel your contractual declaration pursuant to the following terms and conditions:

1.1 Notice of cancellation if the goods ordered come in one package:

The cancellation period is fourteen days from the day when you, or a third party appointed by you that is not the forwarding agent, took possession of the final merchandise item.

This cancellation period comprises fourteen days from the day on which you or a third party appointed by you, who is not the carrier, took possession of the goods.
